Director Lamattina moved to approve the 2/20/24 minutes as amended. Seconded by Member Rep Jo-Ellen Courtney. Hearing no objection, Committee Chair Sweet declared the minutes approved by unanimous consent.

2. Member Services Update

Henry Herndon summarized certain highlights from the staff report:

- Monday night Concord City Council approved the committee's recommendation to join the coalition by a 15-0 vote. Concord's next steps are to appoint representatives and sign the JPA. Brian Callnan testified at the City Council meeting and Chuck Willing thanked and commended him for a good job in answering questions and putting to bed any misunderstandings or reservations Councilors may have had.
- Merrimack County Delegation voted on Friday 3/8 to adopt their Electric Aggregation Plan, becoming the second County to do so. Henry Herndon and Brian Callnan presented to the County Delegation of up to 44 House Representatives.
- Yesterday was town meeting and the following CPCNH Members adopted Community Power Warrant Articles: Atkinson; Barrington; Bethlehem; Bristol; Boscawen; Campton; Charlestown; Epping; Franconia; Hampton Falls; Kensington; Loudon; Lyme; Newport (passed in 2023 but hasn't launched yet); Randolph; Springfield; Somersworth (passed by City Council earlier this year); Sugar Hill; Tamworth. The Town of Lancaster's Community Power Warrant article did not pass. The Committee discussed Lancaster's unsuccessful vote; Member Rep. Mark Terry suggested it could be helpful to have an Ambassador discuss with folks in Lancaster; Henry Herndon reported that there may have been a disconnect between the Electric Aggregation Committee and the Select Board.
- CPCNH's recent press release has been picked up by sources such as concord monitor, NPR, etc.
- Survey on projects and programs has been published and getting good responses
- Two-pager on financial reserves has been published. The Committee discussed the graphic comparing CPCNH rates to Unitil and Broker rates, and agreed staff may work offline to refine the graphic.

 - Jo-Ellen made a new customer information sheet that summarized CPCNH and process for when new people move in
 - Should mention about quarterly sweep notify them that they will be reached out every quarter but don't need to wait until then to enroll
 - (Mark Terry) Should highlight the phone number since it is easier and we have had a lot of positive feedback in regards to the call center
 - New Member Rep in Lebanon: should we start an opt-up campaign
 - town specific our CPCNH develops it
 - Committee would like CPCNH to develop these materials to help with an optup campaign — want to keep consistency
 - Craig Putnam: ability to choose a discretionary reserve materials CPCNH create materials to help give guidance to these communities and educate them on how these are written and how it can play out and what it may look like in different communities
 - issues arise with the public because it can be perceived as a tax (Jo-Ellen)
 - Clifton Below suggests not calling it tax since it does not fit all the criteria of a "tax" since people don't have to pay it if they just switch energy supplier it is just a part of the electric rate
