C. Below motioned to approve with two minor amendments. P. Kulbacki seconded. Vote: 5 yes, 1 abstention

#### 3. Review RFP Evaluation Criteria and Methodology

M. Miller: Added some notes to the criteria spreadsheet about how the evaluation process might proceed. After initial review the RMC group needs to collaborate for a full day meeting.

Former process of producing a master evaluation criterion and use already formed list as a starting point.

Then RMC will move to short list proposals at the end point.

- N. Devonshire: Do we need 50 data points on every RFP response? It might be too much to do this for all of the proposals.
- C. Below: Maybe there are three categories, in the running, potential (worth evaluation), not worth advancing.
- S. Golding: Ranking by sections may be appropriate because vendors aren't likely to provide comprehensive services across the board.
- S. Golding: There needs to be a minimum number of members involved in the initial review process but maybe more members are required for short list process.
- M. Miller: Vast majority should be submitted on the 15th and the big evaluation meeting should happen during the last week of June.
- C. Below: Need to have the RMC address requests for clarification.
- S. Golding: Could there be email based consensus on "short list" going into the meeting?
- N. Devonshire: Spreadsheet with all respondents and space for comments from evaluators. Would save everyone significant amount of time.
